Here is a listing of funds established within the Hillsboro Community Foundation. Each of these is open for additional contributions: Enclosed is my/our contribution to the:

- Hillsboro Area Impact Fund an undesignated endowed fund established to enhance the quality of life for all residents of the Hillsboro area. Grants are distributed annually to deserving community groups through an application and selection process.
- Clariece and Dean Schroeder Endowed Fund for Scout House Maintenance - This fund will provide for ongoing maintenance of this attractive log structure.
- Marga Ebel Health Fund an estate designated for the health and welfare of the children in the community.
- Kansas Health Foundation Fund -this fund will enhance and encourage healthy lifestyles in Hillsboro and surrounding areas through education, recreation, and all things connected to good health
- Hillsboro High School Citizenship Award Fund - established so each year funds will be used exclusively for the HHS Citizenship Award.
- Hillsboro Senior Center Endowment Fund earnings will provide for support of ongoing programming and facilities of the local senior center.
- Hillsboro CF Operating Fund
- C.M. Sextro Memorial Math Scholarship Fund - each year funds are awarded to gualifying HHS graduates who have indicated a desire to further their education with a curriculum involving higher mathematics.
- John A. and Harriet Kizler Wiebe Fund for Hillsboro High School designated gift for HHS graduating seniors.
- Hillsboro Kiwanis Opportunity Fund an endowed gift fund supporting charitable activities and designed to enhance the quality of life in the Hillsboro and surrounding communities.
- Hillsboro Area Community Arts Endowment Fund established to promote and enrich our community through various expressions of the arts.

- David F. Wiebe Memorial Fund for Hillsboro Pioneer Adobe House and Museum – Endowed fund to ensure the future of the House and Museum and to preserve the history of the Mennonite culture.

The mission of TSA is to foster personal growth, leadership and opportunities in science, technology, engineering and mathematics (STEM). The grant will be used to update software used for design, analysis and construction of solutions for competitive events.

It began with a dream of several 4-H leaders and alumni in 2001 to create an endowment fund to help the 4-H clubs of Marion Country. That dream with a beginning goal of \$10,000 has grown today to over \$55,000 Endowment Fund. We were able to raise this balance through fund-raisers and gifts from both individuals and local business owners.

Working with the Hillsboro Community Foundation has allowed our Endowment Fund to be visible in Marion County. One key decision made by the 4-H committee was to transfer funds from CD's paying low interest to the Hillsboro Community Foundation and setting up the Marion County 4-H Endowment Fund with HCF. Our partnership with HCF will help our fund be visible and to grow in the years to come.

### Connecting donors who care with causes that matter

Hillsboro Community Foundation was formed in early 2004 with 7 board members. It was announced at a special meeting of community leaders and from that meeting 19 households contributed startup funds of \$2,250. Today, we have a board comprised of 12 diverse community leaders and a parttime director. HCF manages \$1,559,433 in assets, and has awarded over \$398,000 in grants and scholarships.

HCF exists to promote and facilitate charitable giving in support of projects and programs that enhance the quality of life in Hillsboro. In fulfilling that mission, the

\$55,000, we now can use the proceeds to really help 4-Hers today. This past year we gave \$1,700 in scholarships to help with the cost of attending 4-H camp at Rock Springs 4-H Center in June. In addition, we awarded 3 \$500 Scholarships to 3 senior 4-Hers that completed 12 years in 4-H. This brings us to a total of over \$3,000 given out this past year to help 4-Her's in Marion County.

What began as a dream is now an active Endowment Fund that can make a difference. In the past 6 years, over \$8,000 has been given back to Marion County 4-Hers. Our fund is doing what our founders hoped it would do. Today, our goal is to reach an Endowment Fund balance of \$100,000 so we can do even more for 4-Hers in Marion County.
